

Appointment of a Person with Parental Power in terms of Section 1 (1), No. 4 of the German Protection of Young Persons Act [Jugendschutzgesetz – JuSchG] and consent under data protection law ("Parent/guardian form")



Preamble

RB Leipzig e.V. – hereinafter referred to as Organizer – and Porsche Leipzig GmbH as partner organize a football tournament consisting of various individual events for boys and girls born between 2008 and 2013 (hereinafter referred to as Leipziger Viertelfinale). In order to ensure that the tournament runs smoothly and safely, the teams may only participate in the events under the supervision of a team leader. This person will supervise the children of his or her team during the tournament as a Person with Parental Power.

The present parent/guardian form regulates (i) the delegation of parental responsibilities to the team leader in the function of a Person with Parental Power in terms of Section 1 (1), No. 4 of the German Protection of Young Persons Act [Jugendschutzgesetz – JuSchG], which is limited to the events taking place within the course of the „Leipziger Viertelfinale“, and (ii) the consent to the creation and publication of photo and film recordings.

Section 1 Delegation of parental responsibilities / Appointment of a Person with Parental Power

Section 2 Declaration of willingness to accept parental responsibilities by the Person with Parental Power / team leader

confirm that I am willing to accompany the children entrusted to me to the sports events taking place within the course of the „Leipziger Viertelfinale“ as team leader in the function of a Person with Parental Power in terms of Section 1 (1), No. 4 of the German Protection of Young Persons Act [Jugendschutzgesetz – JuSchG]. My function begins with taking the child from the care of the parents and ends with returning the child to the care of the parents. During this time, I am obliged to supervise the minors and will especially take care of the compliance with the German Protection of Young Persons Act [Jugendschutzgesetz – JuSchG]. I am aware that the events may be cancelled earlier than planned, e.g. due to special weather conditions. In this case, I will continue to perform my function until the children can be returned to the care of their parents.

Section 3 Consent to the creation and publication of photo and film recordings

For promotional purposes of the Leipziger Viertelfinale, the Organizer would like to have photos and videos of the event taken by agents as well as by representatives of the press, edited if necessary, and subsequently published both in digital form and in the classic print media. The interest in publication also extends to the recordings that participants make available to the Organizer. In this context, it cannot be ruled out that individuals may be identifiable as such.

By signing this form, I, as Custodial Person, and also on behalf of the child, confirm that I agree that such photos and videos may be taken, edited and published. Insofar as the recordings give any indication of my ethnic origin, religion or health (e.g. skin color, headgear, glasses), my consent also refers to this information. I can withdraw this consent at any time. The withdrawal of consent shall not affect the lawfulness of processing carried out based on the consent before its withdrawal.
